daughter of Thomas and Martha Honor (Champion) Ellison of Hempstead.

As "George Baldwin alias Benham," at Huntington, Long Island, Court on 21 February 1680/1 he was a party in a dispute with Jonathan Rogers relative to a barrel of cider, at which time he signed by mark on a document discharging Rogers from debts due to him. Henceforth called "George Baldwin," on 21 December 1681, he acknowledged having received from Joseph Baldwin his part of the estate of "my desesed father [sic, foster father] Georg Baldin" of Hempstead. At Huntington Court on 1 March 1682/3, stating his age as about 27 years, he testified in a suit between Henry Soper and Jonathan Rogers. At Hempstead on 3 March 1683/4 he registered his cattle earmarks. He contributed toward the patent of 1696, and was listed with his wife in the 1698 census of Hempstead, then owning a large amount of land.<sup>90</sup>

His wife Mary apparently having predeceased him, George Baldwin made his will on 9 January 1730/1. It was proved at New York City on 25 February 1730/1. 91

George and Mary (Ellison) Baldwin's twelve children and many descendants are identified in Seversmith's Colonial Families of Long Island 198-210, and will not be repeated here.

## JOHN BRISCOE

1. Doctor John<sup>1</sup> Briscoe was born c1612 at Crofton Hall, County Cumberland, England, the fourth son of Leonard Briscoe. <sup>92</sup> His death date is not known. He married, date unknown, Elizabeth Dubois, who was probably born in England of Huguenot ancestry. Doctor Briscoe was probably an Anglican, but his descendants married into Roman Catholic families of Maryland. <sup>93</sup> He accepted the invitation of Cecil Calvert to come to Maryland as one of the Gentlemen Adventurers on the Ark and the Dove Expedition. A Briscoe descendant is stated to have had a letter

dated 1 September 1633 in which Cecil Calvert wrote to "Dr. John Briscoe, M. D., Brikskaugh, Newbiggin, Cumberland," telling him that the *Ark* and the *Dove* would sail from Gravesend on 1 October, and inviting him to join the expedition.<sup>94</sup>

John Briscoe was a member of the court that met at St. Mary's City. In 1642 the name of John Brisquett appears twice in an assessment. In 1642 the name of John Briscoe should not be confused with a contemporary named John Biscoe. The ancestor of the Briscoe family is usually referred to as Doctor.

Some sources say that Doctor John had a son, John Jr., who was the father of Philip Briscoe, but if the latter was in fact born in 1648 he is most likely to have been a son and not a grandson of the Doctor. Pye states that Philip was a son of Doctor John. Alice Ijams Williams, using data compiled by Katharine Spencer Heywood of Pittsburgh, Pennsylvania, in 1854, states that Doctor John and Elizabeth DuBois Briscoe had at least three children.

He made his will on 9 May 1718, proved 11 November 1718. He named his wife Ann and children: Thomas, John, James, Mary, and Anna. Jas. Edmonds and Bryan Dulsey (Dussey) were witnesses. No inventory or account of the administration of the estate have been found filed in the Prerogative Court.

John Briscoe is believed by some to have had a daughter Elizabeth who married Captain Thomas Attaway. A study of other sources has failed to

find proof of the marriage.99

John Briscoe was the father of:

- Thomas<sup>3</sup> Briscoe, d. c1697 when his estate was valued at 35,374 lbs. tobacco.<sup>100</sup>
   Dr. John Briscoe, probably the John Briscoe, Jr. who with Philip Briscoe witnessed the will of Susanna Briscoe on 5 Feb. 1739/40.<sup>101</sup> He may have

- 4. Philip<sup>2</sup> Briscoe, son of Doctor John and Elizabeth, was born c1647/48 and died in Charles County by January 1724/5. About 1719 he made a deposition giving his age as about 72, saying he saw a bounded white oak in a gully belonging to Luke Barber, where he himself lived some 50 years earlier. 102 He married Susannah Swann, daughter of Edward Swann. She died by July 1740 in Charles County. 103 On 19 June 1707 she signed the inventory of the estate of her brother James Swann of St. Mary's County. 104

Philip Briscoe was one of the coroners of Charles County, and later one of the Magistrates, Justices and Chief Civil Officers of Charles County. He also served on the vestry of King and Queen Anglican Parish, St. Mary's County, in 1692 and 1697. He was a delegate to the Lower House of the Assembly, representing Charles County, 1699-1700. 106

His will was dated 25 April 1724, proved 29 January 1724/5, and named wife Susannah, who was devised the dwelling plantation *Morris' Venture* for life, then to son John; to son Philip the 80 acres "bought from Father Swann;" son Edward was devised *Hitchen* and 111 acres of *Love's*

Enjoyment; deceased son George (who left a son Leonard) and daughters Sarah Leonard [sic], Judith Ashcom, Susanna Compton and Ann Wood. Son James was devised 200 acres of Love's Enjoyment. At his death his total estate value was £671,19.9 (including 14 slaves and numerous books). After his debts were paid, a final balance of £490.7.2 remained for distribution. An account of the administration of his estate was filed on 3 December 1725 by John Briscoe, executor. Legacies were paid to wife Susannah, Susanna Compton, Ann Wood, Charles Ashcom, and William Howard. 108

Susannah Briscoe died in Charles County leaving a will dated 5 February 1739/40 and proved 24 July 1740. She named her brother Samuel Swann, daughter Elizabeth, children of her deceased son John, viz.: Samuel Williamson, Philip, James, Hezekiah, John Briscoe, and Martha Willson; her daughter Ann Wood and Ann's daughter Mary; granddaughter Elizabeth Garner; grandson William Howard and all the remaining children of daughter Sarah Howard; granddaughter Sarah Parker; granddaughter Susanna Whitely, and all the remaining children of daughter Susanna Compton; grandsons Briscoe and George Davis; grandson Robert, son of Edward; grandson Leonard; children of deceased daughter Judith Brooke; and grandchildren Rebecca and Williamson Briscoe and Henry Smoot. Sons Philip and James were appointed executors. The will was witnessed by John Briscoe, and Philip Briscoe (both minors). No inventory or account of the administration of the estate of Susannah Briscoe was filed in the Prerogative Court.

10. Captain John<sup>3</sup> Briscoe, son of Philip and Susanna (Swann) Briscoe, was born c1678 and died by 10 May 1734 in Charles County. He married Eleanor Williamson, possibly born c1680, died in Charles County c1753. 110

On 12 June 1722, John Briscoe of Charles County, gentleman, conveyed to Henry Wharton of St. Mary's County, part of *Baltimore's Guift*, which William Digges of Prince George's County had conveyed to him on 23 June 1719. His wife, Eleanor, consented.<sup>111</sup>

Capt. John Briscoe's, inventory was taken on 10 May 1734 and valued at £322.00, with son Samuel Williamson Briscoe named as principal creditor; he and John Briscoe signed as next of kin. 112 Elioner Briscoe, executrix, filed the administration account of the estate of her husband on 12 April 1735. Payments totalling £15.11.6 were taken out of the inventory of £323.0.0. No heirs were named. 113

On 5 September 1738 John Lewellin of St. Mary's County leased to Eleanor Briscoe for 21 years, 102 acres of *Wood Manor* in Charles County. The lease stipulated that Eleanor was to plant 100 apple trees within 10 years. <sup>114</sup> On 6 September 1754, Samuel Williamson Briscoe, son of Eleanor Briscoe, and Hezekiah Briscoe, son and executor of the said Eleanor, conveyed to John Lewellin 102 acres of *Westwood Manor*. <sup>115</sup>

Elizabeth, on 19 June 1725 conveyed to Samuel Swann 80 acres, part of Eggleston, formerly belonging to Edward Swann. 118

The personal property of Philip Briscoe was appraised at £273.19.0 by Luke Barber and William Bond in November 1743. Richard Wanright and Philip Briscoe signed as next of kin, Elizabeth Briscoe filed the inventory on 6 February 1743/4.119 Payments were £301.15.9. The balance (sic) was distributed with one-third going to the widow, and the balance to the orphans [named below]. 120

12. Edward<sup>3</sup> Briscoe, son of Philip and Susanna (Swann) Briscoe, born c1685 and died in 1726, having married Susanna Gerard.

Edward Briscoe died leaving a will dated 7 December 1725; proved 19 February 1725/6. He named his wife Susanna as executrix and his children Philip, Robert (devised Love's Enjoyment), Edward (devised Hitchen), John, George, Lydda, and Priscilla, and a posthumous child. William Wood, George Saint Clare, and Matthew Parlow were witnesses. 121 The estate of Edward Briscoe of Charles County was appraised by John Chunn Jr., and Benjamin Chunn, and was valued at £194.16.7. Philip Briscoe and Thomas Masser signed as creditors. John Briscoe Sr., Susanna Briscoe Sr., and John Briscoe Jr., signed as next of kin. 122 Susannah Briscoe, executrix, filed the account of the administration of the estate of her husband on 21 August 1727. Payments totaled £2.8.1 and were made to Thomas Reed and Samuel Hanson. 123

Samuel Williamson and Francis Clarke appraised the personal estate of George Briscoe on 9 March 1720 and set a value of £152.1.1 on his personal estate. Philip and Susanna Briscoe [probably his parents] signed as next of kin. Mary Briscoe, administratrix filed the inventory on 6 June 1721. On 5 July 1726, Mary, wife of William Tippolls, filed the account of the administration of the estate of George Briscoe of St. Mary's County. His personal estate had been appraised at £152.15.1<sup>126</sup>

Thomas Truman of Prince George's County died leaving a will dated 15 September 1717, proved 14 January 1717/8. He named his mother, Mrs. Jane Taney, his oldest son Henry, son James, his own brother Edward, daughter Jane, nephew Thomas Truman, and wife Sarah, executrix. The will was witnessed by Thomas Greenfield, and Philip Willisey. A codicil dated 15 September 1717 stated that his brother Edward was to be discharged of his debt to the testator if he should convey *Thomas and Anthony's Choice* to the testator's son James at once. 127 An account of the administration was filed on 23 October 1719 by Sarah Truman. She

reported an inventory value of £602.16.11, and a second inventory value of £98.7.10. Payments totaled £72.15.9. Truman's mother Jane Taney was mentioned, and the legal representatives named were: the widow Sarah and children: Henry, Jane, James, and Thomas. 128

William Stevens Howard was a son of Edmund Howard, gentleman, of Charles County, whose will dated 3 December 1709 named the children of William Stevens Howard. William married first, Eliza, and was the father of Edmund and Elizabeth. 129 He died in Charles County leaving a will dated 15 December 1733, proved 29 April 1734. He appointed his wife Sarah executrix. He mentioned his eldest son Edmund, a daughter Rachel, wife of Matthew Compton, and his four younger children: William, Elizabeth, Susannah, and Sarah. The will was witnessed by Benjamin Douglas Sr., Philip Jenkins, and Benjamin Douglas Jr. 130 Henry Truman, executor of Sarah Howard [now deceased], the original executor of William Stevens Howard on 3 June 1736. An inventory value of £474.15.6 was listed and payments totaled £102.12. 131

Sarah (Briscoe) (Truman) Howard died in Charles County leaving a will dated 16 April 1735 and proved 20 May 1735. She named her sons Henry Truman, James Truman, and William Howard, daughters Elizabeth and Sarah, and grandson Henry Smoot. Later she named her children William, Elizabeth, and Sarah Howard, her deceased husband William Stevens Howard and his son Edmund. Her sons Henry and James Truman were cautioned to behave with tenderness toward Edmund Howard. George Dent and Anne Smoot witnessed the will. Henry Truman administered Sarah Howard's estate on 22 February 1736. An inventory value of £487.13.3 was listed, and payments totaled to £49.18.2. No heirs were named. 133

15. Judith<sup>3</sup> Briscoe, daughter of Philip<sup>2</sup> and Susannah (Swann) Briscoe, died by 1739. She married first, by 1723 Charles Ashcom, who died in 1726 in St. Mary's County, and second, between 23 March and 5 September 1727, Thomas Brooke; after her death Thomas Brooke married second, Sarah Mason.<sup>135</sup> On 21 October 1717 Winifred Ashcom made a will naming her brother Charles, her niece Martha Ashcom, and other relatives.<sup>136</sup>

Martha Dansey, widow and mother of Charles Ashcomb, of St. Mary's County, made a will on 19 February 1723/4. She named her daughter-in-law Judith Ashcom, granddaughters Martha and Susannah Ashcom, and granddaughter Elizabeth wife of William Shelley. She bequeathed to her grandson Samuel Ashcom money in England, and stated that if any of her grandchildren married Roman Catholics they were to forfeit their bequests. <sup>137</sup>

Charles Ashcom of St. Mary's County was the son of Charles and Martha [-?-] Ashcom. He died by March 1726/7, 138 leaving a will dated 20 November 1725 and proved 23 March 1726/7. His wife Judith was named executrix. He named his children Martha, Susannah, Elizabeth (not yet 16), and son Samuel. He left personalty to Joyce Haines, Richard Ward Key, and Philip Key. He named his grandmother Martha Dansey and Elizabeth Shelley. To daughter Martha was devised 100 acres of Ashcom's. To son Samuel was devised Point Patience, Marsh Neck, and Town Neck. The will was witnessed by Grace Clelan, Magdalen Tomlinson, Richard Deaver, Thomas Truman Greenfield, and Ellis Slater. 139 Executrix Judith Brooke filed the inventory of the estate of Charles Ashcom on 5

September 1727. John Cartwright and John Burroughs had appraised his personal property at £939.8.9. Elizabeth Greenfield and Elizabeth Jenifer signed as next of kin. An additional inventory value of £36.6.6 was filed 29 May 1728. An account of the administration of the estate of Charles Ashcom of St. Mary's County was filed by executrix Judith, now wife of Thomas Brooke, who filed an account on 29 May 1728. An inventory value of £979.15.8 was listed and payments totaled £116.18.8. Another account was filed on 21 November 1732. 141

Thomas Brooke was a son of Thomas and Lucy (Smith) Brooke. He died leaving a will dated 2 September 1748, proved 15 June 1749. He named his wife Sarah, his sons Walter and Richard Brooke, and his eldest son Thomas Brooke. He also named his brother Richard Brooke. Elizabeth, Richard, and Isaac Brooke witnessed the will. On 26 November 1750 Sarah Brooke, executrix, filed an account of the administration of the estate. An inventory value of £472.0.0 was cited, and payments totaled £142.17.9.

16. Susanna<sup>3</sup> Briscoe, daughter of Philip and Susanna (Swann) Briscoe, died c1739. About 1704 she married Matthew Compton, born c1671, died 1747.

Matthew Compton died leaving a will dated 19 March 1744/5, proved 15 September 1747. He devised to his son Samuel all his estate in Virginia. He named his daughters Susanna Whitely and Elender Slye, and a grandson Matthew Compton Parker. The residue of his estate he bequeathed to his son Matthew. George Briscoe and William Howard

## WILLIAM BROWN

1. William<sup>1</sup> Brown, passenger on the Ark and the Dove, was born c1623 (giving his age as c20 in 1643), and came to Maryland in 1633 as a servant of Captain Thomas Cornwallis. 240 He died c1665/6. He married Margaret [-?-]. A Roman Catholic, he settled in Bretton Bay, St. Mary's County. Jnº Thimbelby and William Brown gave a power of attorney to George Manners to take legal action against John "Hollis" (Hallowes) c1648/9. 241 On 2 December 1659 he was named as executor in the will of John Thimbelby. Thimbleby left property to the Roman Catholic Church, to John Brown, and to Margaret wife of William Brown, as well as making other bequests. He left all his land in Maryland to his goddaughter Mary Brown.242 William "Broune" of St. Mary's County died leaving a will dated 27 February 1665 and proved 26 July 1666. He named his children John and Mary who were to share his personal property in equal proportions, but Mary was also to have the personalty given to her by her godfather
